- Working as operations lead in the Capital investment project for building and commissioning of the manufacturing unit.
- Responsible for operative takeover of the new plant (after operational qualification, before

- Planning & Supervision of production activities to ensure products are manufactured and delivered safely, timely, cost effective with the required quality.
- Ensuring the technical availability of the plant also with respect to regulatory requirements (Safety, cGMP)
- Responsible for developing continuous improvement programs to reduce cost and increase productivity through Operational Excellence and Innovation initiatives
- Developing department goals and strategy and prioritize with respect to overall goals of Lonza and BU Bioconjugates.
- As a member of the Bioconjugates Operations Leadership Team responsible for all aspects representing the PCP facility.
- Ensures and manages the interfaces between Manufacturing, MSAT, Plant Engineering, Support, QA and QC.
